## Australian Centre for Montessori Studies (ACMS) Report A summary of the most recent audit information for our RTO

ACMS operates in all States and Territories including Queensland. As a Queensland Pre-qualified Supplier under the User Choice 2010 – 2015 program, our RTO, Australian College of Montessori Studies (ACMS) is required to publish the outcomes of the last RTO audit undertaken by the regulator. We were audited against the AQTF national set of standards which assures nationally consistent, high-quality training and assessment services for the clients of Australia's vocational education and training system.

An AQTF audit was conducted in 2009 and the RTO was found fully compliant with the requirements of the AQTF *Essential Conditions and Standards of Continuing Registration*. This confirms that ACMS is achieving quality training and assessment outcomes.

The User Choice program provides public funding for the delivery of accredited training to eligible Apprentices and Trainees. This audit history information is published to assist apprentices, trainees and their employers to make informed decisions regarding their selection of an RTO for the delivery of training and assessment services.
